## **PROCEDURES FOR OBTAINING ZONING PERMITS**

The procedure for obtaining a Zoning Permit is outlined in the Wind Gap Borough Zoning Ordinance, pages 8-1, 8-2 and 8-3. A copy is available for review at the Borough Office. This information sheet should serve only as a guide to assist a prospective applicant in applying for a permit.

**APPLICATION:** An application for a Zoning Permit is required when a person is desiring to undertake any new construction, structural or site alternation, or changes in use of a building or lot.

The application must include the deed owners name, the proposed construction or use, the estimated construction cost, and the location of the site for which the permit is being requested. The applicant must also submit a plot plan drawing which depicts the locations and dimensions of the lot area and the proposed use of buildings and/or land. The applicant will then submit the application and plot plan to the Zoning Officer. As each situation differs, the Zoning Officer may request additional information to ensure that what is proposed conforms with the Borough Ordinance.

**DECISION:** The Zoning Officer will render a determination based upon how the proposed use and/or construction is identified in the Borough Zoning Ordinance. At no time will there be any activity requiring a permit allowed until a permit is issued. The Zoning Officer shall issue or refuse a permit within 15 days after the date the application was filed and the Wind Gap Sewer Authority approval has been received.

**ISSUANCE:** If a Zoning Permit is issued, it must be posted conspicuously on the premises. No person shall perform any building or other operations of any kind unless a permit is being displayed as required by the Borough Ordinance. At the time of approval, a fee will be assessed in accordance with the prevailing fee schedule for Zoning Permits.

**CONTRACTORS:** A contractor's license must be obtained by all contractors performing work within the Borough of Wind Gap as required by Ordinance #398. Application fee is \$25.00 and must be approved by the Mayor (there is a 3 day waiting period).

**OCCUPANCY:** If a building permit is required, upon completion of construction / renovations, and prior to occupying the premises, a building code official (third party agency) shall issue a Certificate of Occupancy within five (5) business days after receipt of a final inspection report that indicates compliance with the Uniform Construction Code. A copy of the Certificate of Occupancy shall be submitted to the Zoning Officer. If no building permit is required, the Zoning Officer will issue the Certificate of Occupancy upon completion of construction / renovations, and inspection for compliance with the Zoning Ordinance.

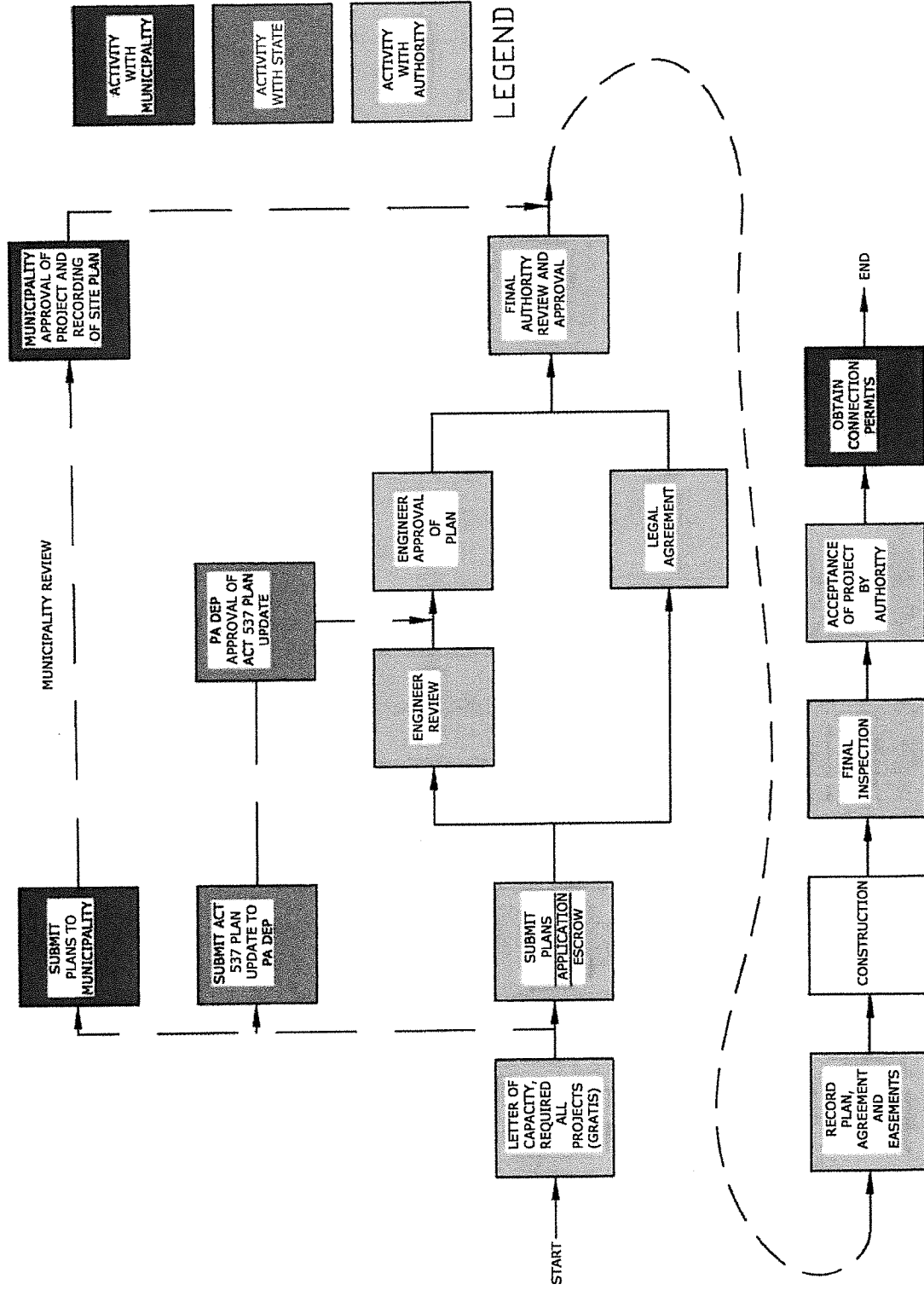

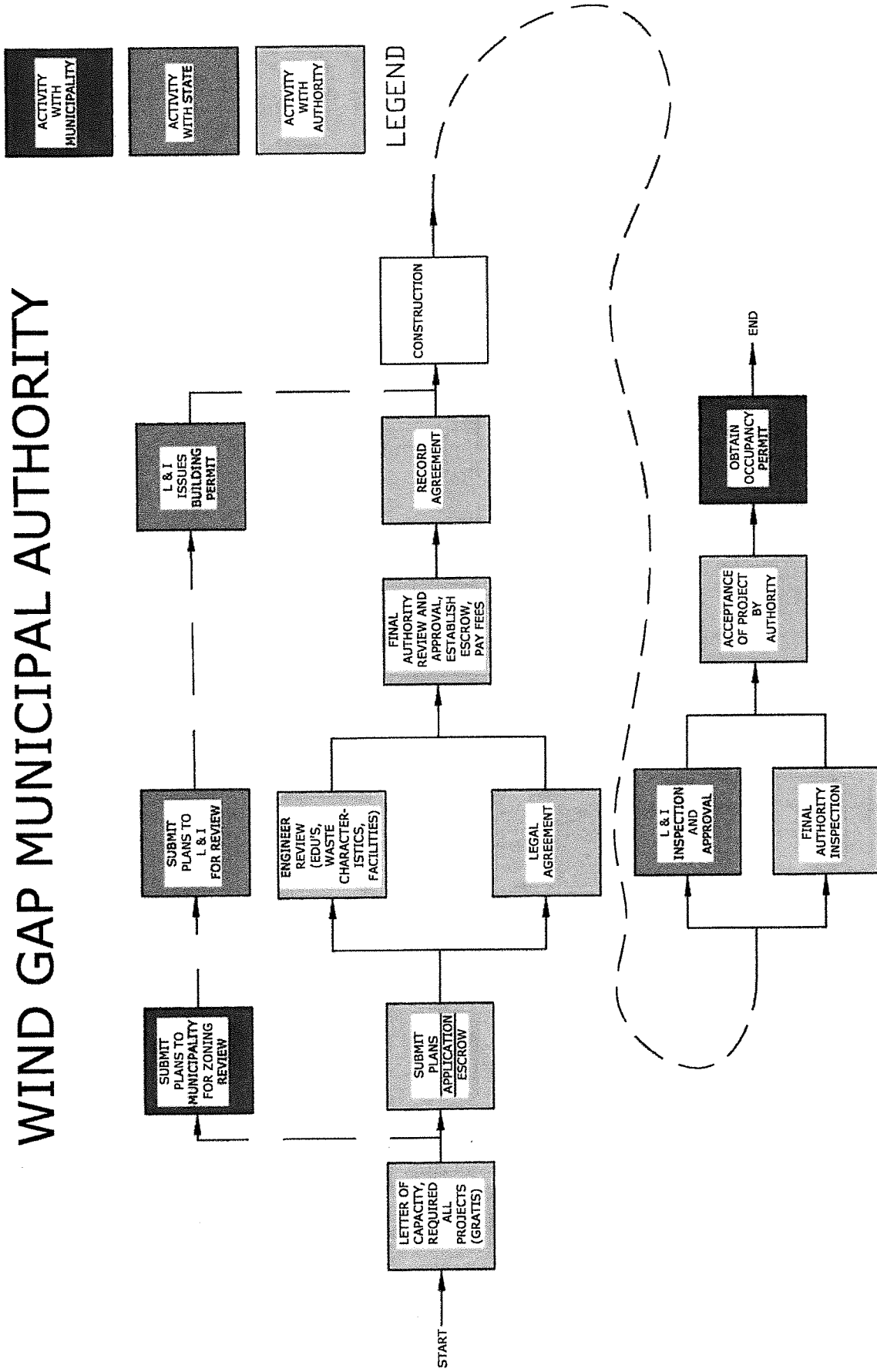

# DEVELOPMENT PROJECT REVIEW FLOW CHART

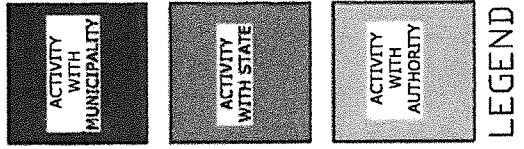
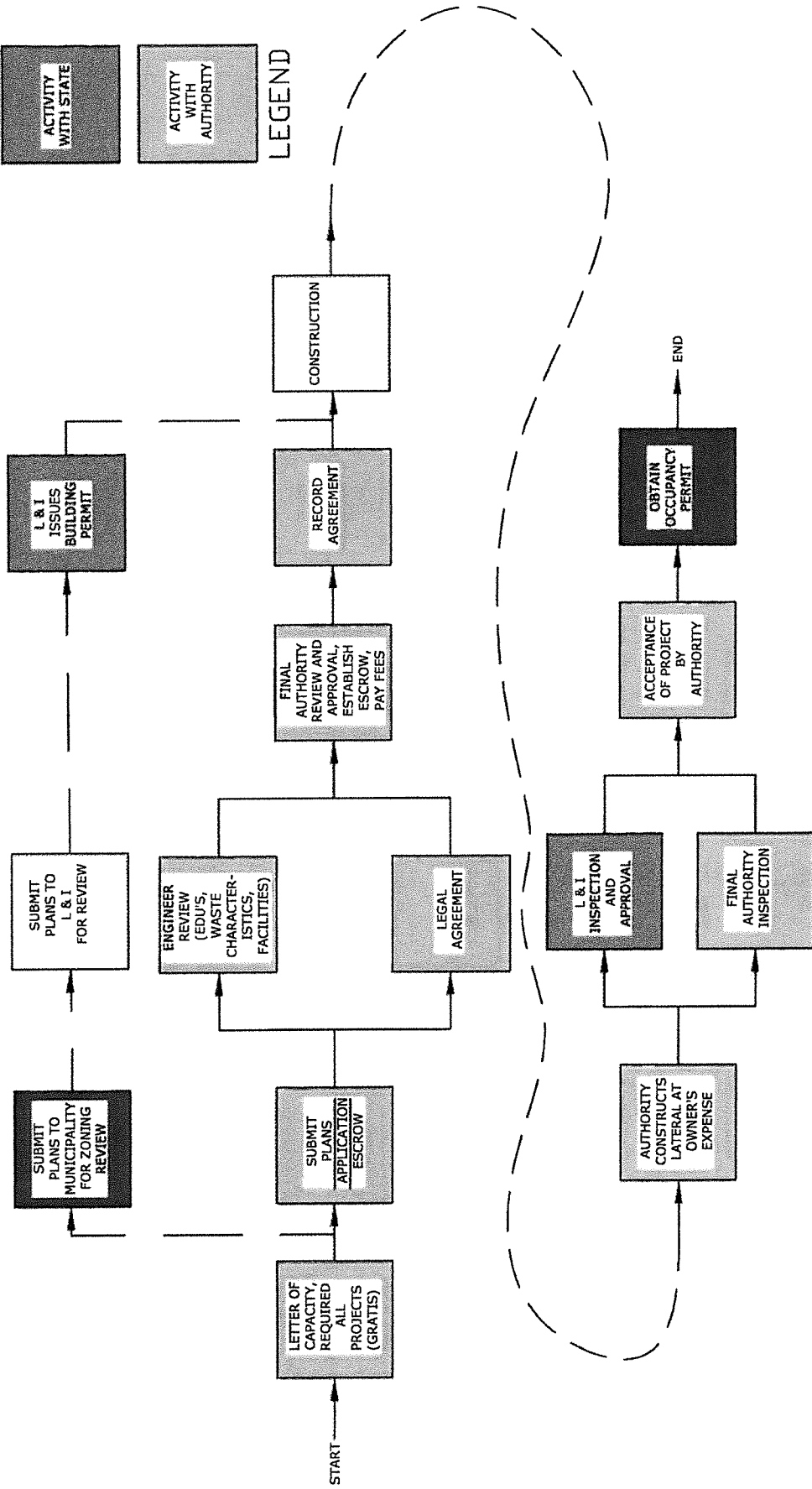

# COMMERCIAL NEW CONSTRUCTION/EXISTING SEWER PROJECT REVIEW FLOW CHART

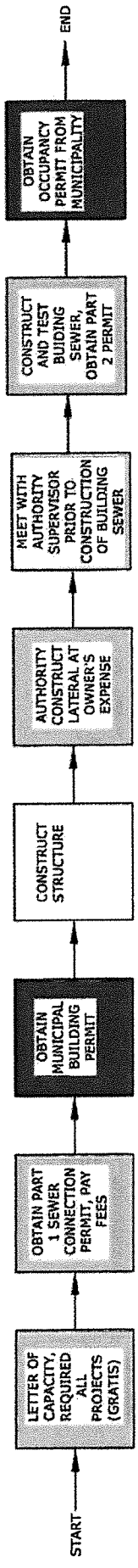
